

ISCA Workshop Proposal to Present at the International School Counselor Collaborative 2021

As we plan for our 15-day Collaborative 2021 we are looking for quality workshops for international school counselors to support their professional development.

Proposals must be submitted no later than May 14, 2021.

The selection committee will review and finalize decisions for workshops by June 1, 2021. All applicants will be notified via email. We encourage you to seek approval from your organization about participating in the event before submitting a proposal.

By submitting a proposal you are stating that if your workshop is accepted you will attend and present at the Collaborative 2021. Registration and fees must be paid by June 30, 2021. Speakers are eligible for the member prices for all package Options A, C and E.

Workshop sessions will be presented virtually, either live or pre-recorded during the month of October. Information about how this will work, and when workshops will be held, will be shared with presenters in early August. As much as possible workshops should be interactive and focused on best practice, research, and should give participants tools, tips and lessons to take apply to their work.

ISCA will work with all workshop presenters to ensure you have sufficient training and skills to deliver a virtual presentation. More information about this support will be shared in June with accepted presenters.
